1. Minutes of previous AGM and matters arising

5. Future of Forum

The Chair gave an overview of the plan and its history for the benefit of the new members. He went on to outline the areas which he felt the Forum could get involved with in the future.

These were:

Review of planning applications

Issues around traffic and traffic calming measures

Public transport

Regeneration of Stanton Hill High Street

Roll out of fibre optic broadband

Protecting access to countryside, including public footpaths and other rights of way

It was suggested that HS2 and Fracking be added to the list.

All those present agreed that the Forum should continue and the future role(s) would be agreed once the full set of officers had been appointed.

6. Fracking

Members of the Skegby, Stanton Hill & Teversal fracking group gave an overview of the current position regarding fracking in the area.

Members of the Forum were urged to sign the petition against fracking.

It was agreed that Jan Jenkins would act as a liaison between the Forum and the fracking group, and that this would be an important area for the Forum to be involved with in the future.

The next meeting of the fracking group is on October 23rd in the Teversal Scout hut.
